Introduction of Tom Armelino

The CCEE Advisory Council welcomed Tom Armelino as the new Executive Director of the CCEE. Armelino reinforced his commitment for collaboration with not only the statewide agencies but more importantly with county offices and school districts.

Information & Discussion

California System of Support

Armelino explained the diagram identifying the redesigned accountability structure. He described the three levels of support:

Level 1-Support for all LEAs Level 2-Differential Assistance

Level 3-Intensive Intervention

Armelino also reviewed how services are accessed through the various organizations: Districts, COEs, Geographic Leads, Community Engagement Leads, Equity Lead, Early Math, MTSS/SUMS, Title III and Special Education Leads.

Staff and Organizational Changes

Armelino discussed the staff changes under the new structure. The key changes are the identification of Directors in four key areas:

- Systems Support and Innovations
- Strategic Partnerships and Personalized Learning
- Continuous Improvement
- Finance and Operations

AB1840 and SB 874 Districts in 'Fiscal Distress'

Armelino explained how districts and county offices can access CCEE services and support. This included the order in which districts can be served accessing funded services; District, COE, Geographic Leads and finally CCEE at little to no cost. However, if a district wants to access services from the CCEE directly there will be a fee for service.

interact with each other. Discussion was held concerning the dollars being allocated to Geographic Leads. It was discussed that while the Leads would be receiving the allocation that the services provided to districts should reflect increased assistance.
