California's Community Engagement Initiative Grows by Six School Districts

SAN BERNARDINO – Six public school districts from across California have been selected to join the Community Engagement Initiative (CEI), an ongoing and innovative effort to create dialog and build relationships with stakeholders.

The five-year initiative is a component of the state's System of Support, which seeks to strengthen outreach and collaboration, address inequities and build the capacity of local education agencies (LEAs) to improve student outcomes.

The CEI is a joint project by the California Collaborative for Educational Excellence (CCEE), San Bernardino County Superintendent of Schools (SBCSS), the California Association of Bilingual Educators (CABE), and Families in Schools (FIS).

The Fall 2020 Cohort II districts join 12 others that have been selected as Peer Leading and Learning Networks since CEI began in 2019. The participants utilize research, policy and peer-to-peer relationships to boost success for diverse populations, including English learners, low-income students and foster youth.
