Consent Agenda Item 2: Professional Service Agreements: Dr. Jennifer Goldstein

It is recommended that the Governing Board authorize and direct Marin County Superintendent of Schools, as Fiscal Agent for the California Collaborative for Educational Excellence, to enter into two contracts with Jennifer Goldstein.

Contract to serve as the primary instructor and lead professor for the LEAD Program. The Agreement is for a term of July 10, 2018 through June 30, 2019, a not to exceed amount of \$65,000.
