Advisory Council Highlights

October 6, 2023

INTRODUCTION

Gary Waddell, Superintendent of Santa Clara Unified School District, opened the Advisory Council meeting by providing new members/visitors the opportunity to introduce themselves. The Council welcomed State Board Chair, Dr. Linda Darling Hammond to the meeting, Erin Gable (Consultant Assembly Budget Subcommittee), Katie Brackenridge-Center for Whole Child Education and Misty Feusahrens (Assembly Speaker's Office).

HOT TOPICS: POLICY & LEGISLATIVE UPDATES

Executive Director, Matt Navo, kicked off our Hot Topic discussion of the new math framework approved at the last State Board Meeting ([agenda](#)), and what the state should/should not do in terms of organizing and building professional learning to support framework implementation.

Dr. Linda Darling-Hammond, President of the California State Board of Education, provided context for the discussion sharing that:

- The US currently ranks about 39th in mathematics internationally
- We teach math differently from the highest achieving counties who teach fewer concepts more deeply, approach math in an integrated fashion, offer more support through extended learning and tutoring, and don't divide students until at least 9th or 10th grade
- With the Common Core, we are trying to get to fewer, higher, and deeper standards

Advisory Council Members provided input, including:

- Professional development, coaching, and support are needed to support an integrated approach
- Questions were posed about how to support mathematics with ELA support
- Need further efforts to align the standards around key concepts and big ideas
- Differentiation support is critical for heterogeneously grouped classrooms
- Early math support has been significant and well-designed

CCEE HIGHLIGHTS

Executive Director Matt Navo introduced Deputy Executive Director, Chris Hartley and Senior Advisor for the Statewide System of Support (SSOS), Mindy Fattig who provided an update on the Statewide System of Support and some data tools that are in development around services and data pertaining to students with disabilities:

- **CCEE Students with Disabilities Data Monitoring Dashboard**
This tool is for COEs and LEAs to see a satellite view regarding their data and monitoring status in serving students with disabilities all in one place for the first time. Utilizing information from the CA Dashboard at the LEA level for students with disabilities and CDE SPED Annual Performance Report (APR) State Performance Plan Indicators (SPPI), data can be viewed and sorted at the state level, county level and LEA level including LEA status in Compliance Improvement Monitoring (CIM). This dashboard will be updated twice a year; at the release of CA Dashboard data (Dec. 2023) and at the release of CDE LEA SPED Annual Performance Reports (approximately March 2024). This tool can be accessed through Geographic Leads, County Office of Educations and/or CCEE.

- **CCEE Differentiated Assistance Dashboard**

This tool is for primarily for COEs in providing Differentiated Assistance supports to LEAs. It provides a summary level report of satellite data directly from CA Dashboard and can be sorted by Geographic Lead region, County and/or LEA level. Data can be drilled down to individual student level data by subgroup as well as providing information on eligibility status for Comprehensive Support and Improvement (CSI) and Additional Targeted Support and Improvement (ATSI). This dashboard will be updated at the release of new CA Dashboard data. This tool can be accessed through Geographic Leads, County Office of Education and/or CCEE.

- **CCEE Statewide System of Support Directory**

This public directory is a searchable database to locate contact information for state agencies, COEs, LEAs and educational partners that comprise the CA Statewide System of Support. This will ensure equity and access to the state funded resources and supports available throughout CA to improve student outcomes and build LEA capacity. The user can search by name and/or initiative and each initiative will have a link to their individual website for more information. This database will be updated as needed to ensure the most accurate information is readily available. The CCEE Statewide System of Support Directory will be located on CCEE's website by mid-October 2023.
