The following objectives for achieving our goal were determined from the feedback from our educational partners, state agencies, and practitioners in the field.

Objective 2: Deliver responsive and impactful resources and services within the Statewide System of Support to support the specific needs of LEAs to improve outcomes for all students. (TSEE)

Objective 3: Facilitate the application of evidence-based continuous improvement processes within LEAs to support student outcomes. (I3)

Objective 4: Identify, vet, and disseminate emerging and best practices, strategies, and resources that address current high-priority needs of local educational agencies, especially as aligned with their LCAP goals. (I3)

Objective 5: Facilitate the analysis of systematically collected data to understand the impact of program activities on improving student outcomes. (I3)

Objective 6: Advise and assist County Offices of Education (COEs) and Local Educational Agencies (LEAs) in need of targeted assistance in achieving their LCAP goals, prioritizing academic achievement by effectively meeting the needs of students who are historically underserved. (TLLC)

Objective 7: Assist COEs and LEAs with achieving the goals and objectives of their LCAPs by empowering teachers and educational leaders with professional learning and resources on evidence-based strategies to accelerate and improve teaching, learning, and leading. (TLLC)
